**Clinton High Student Named Winner of College Savings Iowa 529 Plan**  
*GEAR UP Iowa Program Partners with the State Treasurer's Office to Sponsor Drawing*

**Des Moines, IA., November 7, 2012** – The Iowa College Student Aid Commission (Iowa College Aid) announced today that Clinton High student, Madison Ready, is one of eight high school juniors who will receive an extra \$1,000 to help pay for future college expenses thanks to GEAR UP Iowa's partnership with the Office of State Treasurer Michael Fitzgerald. Juniors attending a GEAR UP Iowa high school and whose parent or guardian completed a GEAR UP Iowa parent survey were entered into a drawing to win one of eight \$1,000 College Savings Iowa 529 Plan accounts. Madison is the daughter of Nicole Dettaven from Clinton.

This year's drawing was the second held by GEAR UP Iowa in collaboration with the Iowa State Treasurer's Office. "We have crafted a very beneficial partnership with State Treasurer Fitzgerald to help inform GEAR UP Iowa students and their families about the College Savings Iowa 529 program," said John Gilman, GEAR UP Iowa project coordinator. "Our goal at Iowa College Aid, the agency that administers GEAR UP Iowa, is to help all Iowans plan, prepare, and pay for college. A College Savings Iowa 529 Plan is a great way to start."

"The advantage to saving and investing for college is clear, and we're here to help. Families who start saving early will be in a better position to meet the challenge of paying for college when the time arrives," stated Fitzgerald. "Our partnership with GEAR UP Iowa allows us to inform students and families across the state who are moving forward on their path to success in some type of postsecondary education about the benefits of College Savings Iowa."

The College Savings Iowa 529 Plan offers an affordable, flexible, convenient and tax-advantaged way for anyone – parents, grandparents, friends and relatives – to invest for college on behalf of a child. An account can be established with as little as \$25. Iowa tax payers can deduct up to \$2,811 in contributions per beneficiary account annually from their adjusted gross income and there are no income, residency or age restrictions.\* Multiple contribution and withdrawal options, plus convenient online account management are real time-savers for today's busy families.

GEAR UP Iowa works to create and sustain a college-going culture through statewide and school-based services provided to a cohort of approximately 7,000 high school students from the class of 2014 in more than 200 Iowa high schools. The program, administered by Iowa College Aid, is funded through a \$16.8 million federal GEAR UP grant. In addition, all students in the GEAR UP Iowa cohort will be eligible to receive a GEAR UP Iowa scholarship upon high school graduation to help pay higher education costs.
